Subject to the terms and conditions stated herein, Heze Xinglin Wood Industry Co., Ltd. warrants its trim and siding products against rot, decay and finger joint/edge glue failure for a period of ten (10) years from date of purchase to the original consumer purchaser. This warranty may not be transferred or assigned.

Each purchaser of Heze Xinglin Wood Industry Co., Ltd products is responsible for following applicable building codes and generally accepted building practices for “finish” lumber and siding and HEZE XINGLIN WOOD INDUSTRY CO., LTD guidelines for storage, handling, installation and finishing of HEZE XINGLIN WOOD INDUSTRY CO., LTD products. Never allow HEZE XINGLIN WOOD INDUSTRY CO., LTD products to directly touch brick, stone, concrete or similar material. HEZE XINGLIN WOOD INDUSTRY CO., LTD products are not for structural use or load bearing applications. HEZE XINGLIN WOOD INDUSTRY CO., LTD products must be kept clean and dry prior to application of finish paint coat or coats. The installer must prime coat any cut ends or tipped edges and any areas around fastening devices, i.e.: nails, screws, staples, etc. with 100% acrylic latex primer or Alkyd oil primer. Failure to follow the above recommended guidelines will void this warranty.

Limitations/Exclusions

This warranty is limited exclusively to replacement of defective product only. under no circumstance shall HEZE XINGLIN WOOD INDUSTRY CO., LTD be liable for mold or mildew growth, extractive bleeding, paint or coating failure, labor for removal, re-installation, cost of replacement material, freight, taxes or any other charge related to the replacement of a defective HEZE XINGLIN WOOD INDUSTRY CO., LTD product.
