

TRI-STATE FOREST PRODUCTS 15 YEAR LIMITED WARRANTY

FOR TRI-SHIELD ROOFING UNDERLAYMENT

Tri-State Forest Products Inc. warrants, to the original Purchaser, roofing underlayment products. Woven configurations, will for a period of 15 years, be free from defects in material and workmanship, under normal and proper use, storage, and operating conditions. Tri-State Forest Products will at its options, replace or repair the defective product returned to the Company (transportation cost for return at the expense of Purchaser), or if repair and replacement are impossible, refund the purchase price, within 15 years from the date of shipment to the original Purchaser.

This limited warranty shall be void in the event of:

- (i) Improper, negligent, abusive or other misuse of the product not intended or authorized in writing by the Company.
- (ii) Alteration or unauthorized repairs to product which, in the Company's sole judgment, would affect the performance, safety or reliability of the products.
- (iii) Failure to give notice, in writing, to the Company of the defect within ten days of discovery of the defect.

The Purchaser will take complete responsibility for the installation of the products of the Company, and will abide by all National and Local codes and laws; (codes and laws may vary in geographical location).

The Company may render advice, recommendations or opinions as to the application, installation or operation of its products, but such advice, recommendations or opinions shall be at Purchaser's own risks and shall not give rise to liability based upon reliance on such advice, recommendations or opinions rendered by the Company.

Submit all warranty claims in writing within 15 days of the defect discovery. Include: a brief description of damaged area, a copy of the dated sales receipt, invoice and evidence of installation date, to:
